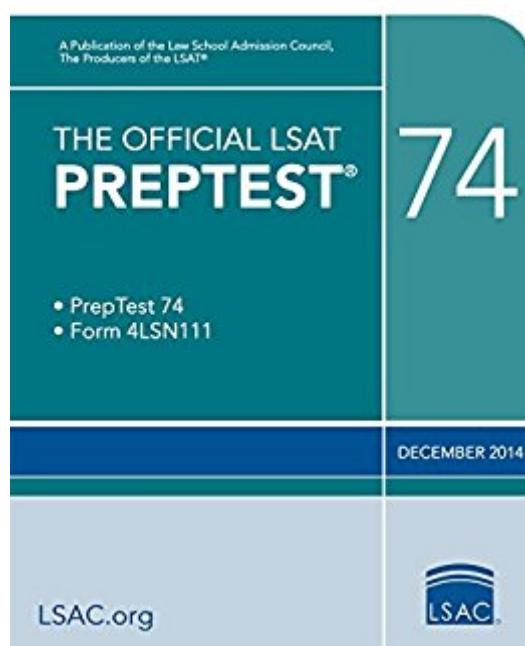

investment you could make towards a better LSAT score. For more practice, get pretests 29-38. Note that only pretests 66-74 have two pages for logic games diagrams. Use only the second page for your diagrams. It is surprisingly easy to lose your train of thought when you have to move your eyes across multiple pages.
